**ORDER**

The Chairman of K.R.Narayanan National Institute of Visual Science & Arts(KRNNIVSA) as per letter read 1<sup>st</sup> paper above, has forwarded a proposal for granting autonomy to KRNNIVSA, as a mandatory pre-requisite, so that the students can be given certificates, validated by the Senate of the Institute. The General Council, the highest decision making body of KRNNIVSA has recommended the proposal for granting autonomy. The Institute is not presently affiliated with any University.

2)K.R.Narayanan National Institute of Visual Science & Arts (KRNNIVSA) is registered under Travancore-Cochin Literary, Scientific and Charitable Societies Registration Act ,1955 and functioning under the administrative control of Higher Education Department. The major amendments include expanding the aims and objectives of the Institute, thereby enabling it to reach international standards and make it on par with other similar National Institutes in India.

3)As per minutes of the meeting read as 2<sup>nd</sup> paper above, it was decided that, the amendments to Rules and Regulations of the society as approved by Governing Council should be approved within one month. Accordingly as per the minutes of meeting read as 3<sup>rd</sup> paper above, the Director, KRNNIVSA was directed to furnish revised proposal of Amendments to Memorandum of Association & Rules and Regulations. The revised proposal was submitted as directed vide reference read as 1<sup>st</sup> paper above.

4)The amendments proposed are with the aim of achieving autonomous status for the Institute and to enable the Institute to develop into an Institution of eminence and excellence. Government, having examined the matter in detail, hereby approve the proposed Amendment of Memorandum of Association and Rules and Regulations of K.R.Narayanan National Institute of Visual Science & Arts (KRNNIVSA), as

appended to this Government Order.
